PROPOSED BYLAWS' CHANGES

The Bylaws Committee of the League of Women Voters of Greater Birmingham, composed of Judith Hand, Chair, Gayle England, Colette Scott, and Becky Sylvester, proposes the following amendment to the Bylaws of the League of Women Voters of Greater Birmingham:

Article VI. Financial Administration

SEC. 2 Dues - Delete current wording:

Annual dues shall be payable at the time of joining, and each anniversary thereafter. Any member who fails to pay dues within two months after they become payable shall be dropped from the membership rolls.

and substitute:

Dues are payable at the time of joining, and shall be due and payable by September 15 each fiscal year thereafter. Any member who fails to pay dues by December 15 each year shall be dropped from the membership rolls. Any person who joins between January 1 and June 30 of each year shall pay half of the annual dues.

CAHABA RIVER WATERSHED WAS TOPIC OF MARCH UNIT MEETING

Beth Stewart with the Cahaba River Society gave an excellent presentation on the upper Cahaba watershed. She focused on the area from Trussville to Helena, discussing past problems and future problems that will affect the river. Many of the problems result from decisions made by each municipal planning/zoning board. Their decisions ultimately go before the City Council of that municipality. This watershed is of great concern since it is our main source of drinking water.

We as a League and as individual citizens can make a difference by speaking out about zoning, especially if it is in the city where you live. Encourage the County Commissioners and State Representatives to support proper planning along the Cahaba River.
